388/1 2023	<p>Chairman's opening remarks: Cllr. Lyle welcomed all present to this meeting of Full Council, and expressed his pleasure at seeing so many members of the public present. He notified all present of the resignation of Lesley Leahy and noted the impact this had had on his workload. Cllr. Lyle reminded those present of the confidential nature of some business conducted in Council and the requirement not to speak of these matters outside the Council chamber. Further, he was at pains to bring to Councillor's attention that no one person could speak for Council, the body corporate, any representation from members of the public must be put before the Council during the time of public speaking as set out on the agenda.</p> <p>During the past month Cllr. Lyle had met with The Surf Life Saving Club, and Cornwall Council, to carry the process forward for the devolution of Trebarwith Strand Public Toilets to This Council. He had received assurance that, although the devolution process may take time to resolve, the toilets would stay open during the coming season.</p> <p>Finally, it was noted that problems caused by condensation in Trevena Square public toilets had been addressed and resolved by a local builder.</p>
