29 - 30 December 2025 to the Deputy Returning Officer, Cornwall Council, Room 4, Chy Trevail, Beacon Technology Park, Dunmere Road, Bodmin, PL31 2FR between the hours of 10.00am – 1.00pm and 2.00pm – 4.00pm

New applications to vote by proxy at this election must be sent to the Electoral Registration Officer by not later than 5.00pm on **Wednesday 21 January 2026**, except in cases where **unforeseen illness, incapacity, occupation, service or employment** occurs after that time, in which case applications may be received by no later than 5.00pm on **Thursday 29 January 2026**.
